- a. Mayor's Office: n/a
- b. **San Diego Police Department:** Jennie Hall reported that there was a discharging of firearms on January 23 at Adams and Mansfield at 11pm. No injuries. Also a robbery at 3166 Adams on Feb. 9. Residential robberies are down.
- c. **Council District 3:** Dion Akers reported that water and sewer work on Adams and 30th is beginning. He and Scott are going to meet with a representative from the mayor's office to determine proper spaces on Adams for bike racks and parking expansion. The marquee is up and running at the recreation center. Todd Gloria has been appointed as chairman of the SANDAG transportation committee.
- **d.** Council District 9: Chris Pearson reported that Ken Irvine of Blue Boheme and Guy Hanford of Ken Video are getting help with clean up of a water project near their properties. Next year there will be a smart transit that will go down El Cajon Boulevard to downtown and the Santa Fe Depot in about 20 minutes.
- d. **53rd Congressional District, CA:** Daniel Hazard reported that he is happy to be our new representative from Susan Davis' office. New outreach ideas for businesses such as exporting are being explored. Please share ideas with Daniel to take to his office.

e. 76th Assembly District: Jason Weisz reported that there is discussion about the reactors at San Onofre. Two new bills: one is about the content of copper-based paint along the coastline and the other is inclusionary housing in new developments for affordable housing. e. Motion to approve the filing of an application with the County of San Diego for Community Enhancement Program grant funding M/S/P Bach/Knab 13 members present, 12 yes

- f. Motion to endorse the utilization of portions of Adams Avenue as the designated race course for the 2013 Rock n Roll half-marathon. Report from Karen Kong, Rock n Roll Marathon staff member.

- g. Motion to approve funding for the 2013 Art Around Adams. Adam Rosen first gave report. Lois Bach provided a motion from the Executive Committee: "AABA will donate \$2000, \$1000 after budget and proof of insurance is submitted and the second \$1000 after the event, proper receipts are turned into the AABA office, and proper clean-up after the event is completed in preparation for the next morning's Rock and Roll Marathon". M/S Bach/Brierton. Phil Linssen motioned that a limit of \$5000 of AABA funds be put in place for this project with parameters set through the Executive and Finance committees. INFORMATION ITEMS

1. **School Annex Update:** In a year and two months our land lease with the Methodist Church will expire. The church has asked us to stay on as property managers for the school. This issue is going back to committee before any decisions are made.

- 2. Adams Avenue Unplugged Update: The budget went to the Finance Committee. We've lost our vendor base so that is revenue that we will not be receiving. We wrote a grant for \$14,000 to make up the loss. We've also added headliners. We've asked the restaurants to help pay for the performers that will appear in their establishments to offset the cost. We're expecting an actual loss of \$7000 for this event.
- 3. **SDSU School of Public Health Survey:** Shanna Dayan is doing the research with the survey on cigarette butts on the avenue. We took a straw poll and everyone on the board was in favor of the research.
- 4. **Kensington Tree Update**: We spend more money cutting the blight out of the trees than the property owners pay in. Scott attended the planning committee to see what people think. Some want to save the trees. \$12,000 will be the cost to replace the trees and would be covered by a grant from Ron Roberts office.
- **5. 30th Street Update:** We've been doing good work on 30th by moving bus stops at that corner and planting trees on 30th. The water main construction has been reduced from 6 months down to two months.

a. Promotions Committee: Mikey reported that we are encouraging businesses to promote themselves on the AABA website and have a better infrastructure to get out the word on not just our own events but also additional activity on the avenue like the Rock and Roll Marathon.

b. Business Planning & Development: No new information.

c. Finance Committee: Doug reported that we are doing well financially. We have an increased grant request into the city. We might also have monies coming in from the proposed parking program. Report was presented earlier in the meeting because the Treasurer needed to leave the meeting early.
