- 3. Guest Speakers

**a.** City Council District 3: Adriana Martinez reported that this is the city's budget season. The past few weeks have been dedicated to working on the 2016 budget. She encouraged anyone who has some ideas to attend one of the budget hearing meetings and so you can give public comments. 1.2 million has been requested for the Ward Canyon park project. The office acted on a complaint that public restrooms were not available at the Adams Avenue Rec center during all of the hours that children are in attendance. The facility rearranged their hours to accommodate the need.

- 4. **b. Senator Marty Block:** Katelyn Hailey reported that it is budget season at the state level as well. If you have any concerns that you want the senator to focus on, please contact the office. One of his passions is education. One bill SB15, will prohibit college rate hikes by offering grant incentives.

## 4. Discussion Items

a. Review Adams Unplugged: Scott reported that we made \$6000 on the event this year without corporate sponsorship or a Kickstarter program like last year. We raised our grant money by \$14,000 this year over last year. Shayna said that the crowds were really impressed with the music but many people were still referring to it as Roots. Businesses expressed more customers than usual.

- 4. Committee Reports
  - a. Executive Report: Alison reported that the committee reviewed the March financials, Unplugged wrap-up, and drew up the board meeting agenda.
  - b. Staff Report: Steve Florman is working on a plan for what can be done to the 805 bridge for \$80,000. Roses were rejected in planters for more drought resistant plants. Tree grates: five of seven stolen tree grates have been replaced. We are requesting funds to fix the trip-and-falls and tree grates from Supervisor Roberts. The Rock and Roll Marathon will go down Adams on May 31st. The week afterward is Art Around Adams. Taste of Adams is the last Sunday in June.

- c. **Promotions Committee**: Shayna reported that the committee talked a lot about Unplugged. Publicity for the event was covered in a number of city publications. The committee talked about Taste of Adams, which is the last Sunday in June. the next mixer is tomorrow at DiMilles from 5-7pm. The committee talked about the new event in December, the Spirits Stroll, which will take place on an early Saturday evening. The committee also discussed the Loyalty Card that you purchase for \$20 for deals at select Adams Avenue businesses.
- **d. Business Planning & Development:** Alison reported that under capital improvements is the 805 bridge project. The committee discussed the parking structure and possible traffic calming devices, as well as holiday sign lighting and replacement of light posts and trip and falls. They discussed encouraging more walk/bike traffic on the avenue and perhaps approaching MTS about bus number 11 to run later on the weekend evenings to discourage drunk driving. Phil added that several things were discussed and voted down: developing the community center property and swapping it out and the parking garage idea was not accepted by the committee members.
- e. Finance Committee: Doug reported that the committee talked about the March financials and studied the Unplugged budget. They talked about the transfer of funds from checking to savings. Our audit is complete. It will have to be mailed within the next week.
